PAYMENT & SHIPPING INFORMATION

Payment Info Accepted Payment Methods: VISA, MasterCard, AMEX, Discover, Wire Transfer.

You MUST be prequalified in order to bid. There will be a 3% Buyers Fee charged for all Internet Bidding and Phone Bidding. Credit Cards approved for payment up to a maximum of \$6,000 only. To get a limit above \$6,000 please read below. \$6,000 PLUS APPROVAL: To finalize your approval for internet bidding above \$6,000, please contact your bank and have the bank deliver to donrichardsbbusiness@gmail.com or fax to 435-722-5044 one of the following approval forms/letters to complete approval for bidding at the auction;

- 1: Verify that "you are a customer in Good Standing": (provides you to bid amounts at your discretion),
- 2: The bank states they will Guarantee your payment for a specified amount. or
- 3: Provide us with a Letter of Credit.

PAYMENT

If you are the successful bidder of an animal, you will receive an Invoice via email from Basin Premier Horse Sale for the full amount due which includes; 3% internet/phone bidding fee plus a 3% convenience fee if purchased with credit card. No fee if paid for with wire transfer. Payment Terms for internet and phone bids: All buyers must pay for their purchases in full by Monday, April 30, 2018, at 12:00 PM. • All major credit cards. 3% Convenience Fee added if payment made with credit card • Wire transfer – An email will be provided with wiring instructions for the full balance due via a bank wire, the wiring information for payment in full to be wired to Basin Premier Horse Sale first thing on Monday, must be wired no later than the banks cutoff time which is generally noon your local time. Please remember that some banks only wire on the hour and hold wires to be done on the hour or all at once. West Coast is a 1 hour delay in time so please make arrangements to be at your bank when they open! It is best to make arrangements for your wire prior to the Monday noon cutoff. Attention: All phone and Internet bidders waive their rights to reverse payments on all purchases.

GUARANTEE

The buyer will be responsible to pick up the horse by April 30, 2018, or \$20 daily stall and feed costs will be due. Each consignor will be totally responsible for guarantees they make on their animals & guarantees will be made only from the auction block while the animal is being sold. Absolutely no guarantee or warranty will be expressed or implied by the auctioneers or ring men. If you are not happy with these guarantees, please do not purchase a horse from this sale. Every Horse sold at Basin Premier Horse Sale will be guaranteed sound by the consignor. If the horse is not considered sound, the buyer has until April 30, 2018, at 12:00 pm to have a representative from Basin Premier Horse Sale and Dr. Mike Gable look at the horse. A Basin Premier Horse Sale representative will make the final determination as to soundness of the horse. If the horse is considered unsound, the buyer will be returned his purchase price, less fees. The seller of an unsound horse will not be paid for the horse and will be responsible for any fees in conjunction with the sale fees. SOUNDNESS does not guarantee a vet check. If the buyer wishes to have a vet check prior to the Sale, please contact the consignor and make arrangements with a vet near them. Soundness Guarantee is: 1) See out of both eyes clearly and correctly, 2) be correct in the air, 3) will not crib, 4) will beat on all 4 feet soundly.

AUCTION SHIPPING INFO

It is the responsibility of the buyer to make arrangements for transport of their horse once it is purchased. Equine Transporters can be located on the Internet and we would suggest that you find someone that is insured and bonded. We will also have a list in our office of hauling companies available. Shipping arrangements and expenses are solely the responsibility of the buyer.

TERMS & CONDITIONS PRIVATE SALES

Absolutely no private sales with consignors prior to the Sale. Consignors have given Basin Premier Horse Sale Exclusive Rights for selling the consigned Horses. Management feels this is unfair to the consignors and buyers who have traveled to attend the sale. All horses brought to the sale must be consigned and go through our auction ring. The GUARANTEES only apply if the sale is run through the AUCTION. Be sure to call the office and let us know you have made arrangements to purchase one of the horses that did not sell in the Ring to insure all sale

REQUIREMENTS FOR TRANSPORT

Coggins are REQUIRED for transport OUT of Utah: All horses brought to the sale are required to provide a Coggins test current within six months of sale date. Band Inspections are REQUIRED and provided for all Sale Horses: A Brand Inspection (AKA Ownership Papers) MUST BE OBTAINED from the Brand Inspector once you have paid for your horse. Health Papers are REQUIRED for transport OUT of Utah: A Veterinarian will be on the grounds to provide all horses going out of state a current Health Inspection. We pride ourselves on the quick and efficient turn-around time in providing our Buyers the required items for transport by our Brand Inspectors and Veterinarian.

WARRANTY

The buyer assumes full ownership of the animal from the time it is sold in the sale ring and is responsible for proper feed and care. Animals that are rejected by the buyer because they are misrepresented in the ring will need to be inspected by Justin Bastian and possibly Justin's veterinarian and Justin will make the final determination whether there was misrepresentation.

CONDITIONS

Basin Premier Horse Sale & its associates act as agents only and are not responsible for buyer/seller error or misunderstanding. All guarantees are strictly between the buyer and seller. Original Papers must be provided by the Seller to Basin Premier Horse Sale in order for any horse to be sold as a Registered horse. In further consideration of this consignment, you agree to indemnify and defend the Basin Premier Horse Sale, Justin Bastian, Don Richards, Wade Davis and the Basin Livestock Market Committee, their agents and associates, from all injury, loss of equipment, loss of animal or damages to myself, your animals or damages or injury to others or lien property from your animals, by entering this Horse Sale at Duchesne, UT.
